Authorization

1. Salary and expenses for the warden and councillors were paid under the authority of County Council resolution 11/1/07 dated January 25, 2007. This resolution also provides for the annual economic adjustment of such salaries.
2. By-law 4518-02 provides that 1/3 of the remuneration paid to councillors shall be considered as expenses incident to the discharge of their duties and is correspondingly tax-free. This by-law is reviewed once during each term of Council.
3. Per diems payable to citizens appointed to the Wellington County Police Services Board were paid under the authority of County Council resolution 3/9/08 dated November 27, 2008. This resolution also provides for the annual economic adjustment of such per diems.
4. Per diems payable to citizens appointed to the Wellington County Accessibility Board and Library Board were paid under the authority of County Council resolution 14/12/12 dated November 29, 2012. This resolution also provides for the annual economic adjustment of such per diems.
5. Per diems payable to citizens and local councillors appointed to the Green Legacy Committee were paid under the authority of County Council resolution 18/3/16 dated February 25, 2016. This resolution also provides for the annual economic adjustment of such per diems.
