



**THE CORPORATION OF THE COUNTY OF WELLINGTON**

**BY-LAW NUMBER 5306-12**

A by-law to regulate the weight of vehicles passing over certain County Bridges and to rescind By-law 5252-11.

**WHEREAS** subsection 123(2) of the Highway Traffic Act, RSO 1990 Chapter H.8 provides that the municipal corporation or other authority having jurisdiction over a bridge may by by-law limit the gross vehicle weight of any vehicle or any class thereof passing over such bridge, and the requirements of subsection (1) with respect to the posting up of notice apply thereto.

**AND WHEREAS** it is deemed expedient to limit the weight of vehicles passing over several bridges in the Corporation of the County of Wellington.

**NOW THEREFORE** the Council of the Corporation of the County of Wellington enacts as follows:

1. No vehicle or combination of vehicles or any class thereof whether empty or loaded shall be operated over the bridges shown in Schedule "A" to this by-law, in the County of Wellington, where the gross vehicle weight exceeds the weight shown in Column "D" of Schedule "A" to this by-law.
2. Any person violating the provisions of this by-law shall be subject to the penalties provided in section 125 of the Highway Traffic Act.
3. This by-law shall not become effective until notice of the limit of weight permitted in compliance with the regulations under the Highway Traffic Act has been posted in a conspicuous place at each end of the bridge.
4. By-Law Number 5252-11 is hereby rescinded.
