



EMERGENCY ORDER NO. 3

THIS EMERGENCY ORDER ISSUED AND EFFECTIVE SEPTEMBER 18, 2020 AT 12:01 a.m. REPLACES AND SUPERCEDES EMERGENCY ORDER NO. 2 ISSUED JULY 17, 2020

WHEREAS pursuant to subsection 4(1) of the Emergency Management and Civil Protection Act, R.S.O, 1990, c.E.9, as amended (the “EMCPA”), the Warden of the Corporation of the County of Wellington has declared that an emergency exists in the County of Wellington due a public health emergency – COVID-19;

AND WHEREAS pursuant to subsection 4(1) of the EMCPA, the Warden may make such orders as he considers necessary and are not contrary to law to implement the emergency plan of the County and to protect the health, safety and welfare of the inhabitants of the County;

AND WHEREAS under sections 11(1) of the Municipal Act, 2001, the County has broad authority to provide any service or thing that the County considers necessary or desirable for the public, including passing by-laws in respect of the health, safety and well-being of persons;

AND WHEREAS the Medical Officer of Health for the Wellington-Dufferin-Guelph Health Unit has advised as follows:

1. COVID-19, a disease caused by a novel coronavirus, is designated as a disease of public health significance and a communicable disease pursuant to Ontario Regulation 135/18 (Designation of Diseases), as amended, made under the Health Protection and Promotion Act, R.S.O 1990, c. H. 7, as amended (the “HPPA”).
2. COVID-19 can cause acute and severe respiratory illness and death in humans.
3. The spread of COVID-19 is of immediate and compelling public health importance in the jurisdiction of the Wellington-Dufferin Guelph Health Unit:
 - a. On March 11, 2020, the spread of COVID-19 was declared a pandemic by the World Health Organization;
 - b. On March 15, 2020, the first case of COVID-19 was reported in the jurisdiction of the Wellington-Dufferin-Guelph Health Unit;
 - c. On March 17, 2020, the spread of COVID-19 was declared an emergency in Ontario pursuant to the EMCPA, on the basis that COVID-19 constitutes a danger of major proportions;

- d. States of Emergency were subsequently declared by the City of Guelph and the Counties of Dufferin and Wellington (on March 23, 2020) in response to COVID-19;
 - e. As of today, there is evidence of continued community transmission of COVID-19 in the jurisdiction of the Wellington-Dufferin-Guelph Health Unit, as evidenced by newly identified cases not connected to facility outbreaks or travel.
4. COVID-19 is transmitted from person-to-person predominantly through respiratory droplets that are released from the nose and mouth, through contact with contaminated surfaces, and through poor hand hygiene.
5. COVID-19 may be transmitted from persons who have minimal or no signs or symptoms of illness.
6. Accumulating epidemiological evidence indicates that the widespread use of Face Coverings by all persons decreases spread of respiratory droplets, and expert opinion supports the widespread use of Face Coverings to decrease transmission of COVID-19.
7. Use of Face Coverings is recommended by the Chief Medical Officer of Health of Ontario and the Chief Public Health Officer of Canada in situations where physical distancing (spatial separation of individuals by at least two metres) is difficult to maintain.
8. The re-opening of Establishments in Stage 3 has increased the frequency of contact and limit opportunities for physical distancing between persons in the jurisdiction of the Wellington-Dufferin-Guelph Health Unit which, absent adequate preventative measures, will increase the growth rate of COVID-19 cases in the Wellington-Dufferin-Guelph Health Unit.
9. An increase in the number of COVID-19 cases will increase disease transmission, potential for outbreaks in congregate settings, and the morbidity and mortality of COVID-19 within the population of the jurisdiction of the Wellington-Dufferin-Guelph Health Unit.
10. On September 15, 2020, the Medical Officer of Health for the Wellington-Dufferin-Guelph Health Unit issued an Order pursuant to section 22 of the HPPA which Order is attached as **Schedule "A"** to this Order which supercedes the Order issued July 14, 2020 effective July 17, 2020.

AND WHEREAS the Medical Officer of Health for the Wellington-Dufferin-Guelph Health Unit has stated that she is of the opinion on reasonable and probable grounds that:

- a. A communicable disease exists or may exist or there is an immediate risk of an outbreak of a communicable disease in the geographic area served by the Wellington-Dufferin-Guelph Health Unit;
- b. The communicable disease presents a risk to the health of persons in the geographic area served by the Wellington-Dufferin-Guelph Health Unit; and
- c. The requirements specified in this Order are necessary in order to decrease or eliminate the risk to health presented by the communicable disease.

Therefore, I, Kelly Linton, Warden of the Corporation of the County of Wellington, enact, by issuing this Order, the following regulations with respect to the County of Wellington:

DEFINITIONS AND SCOPE OF THE ORDER

An Establishment falling within the scope of this Order is required to make best efforts in respect of the requirements below. In complying with the best efforts requirement, owners and operators shall not require employees or members of the public to provide proof that they qualify for any of the exemptions set out in Section 3.

Definitions

1. For the purposes of this Order the following terms shall have the corresponding meanings:
 - i. “**County**” means the geographical area of the County of Wellington or the municipal corporation as the context requires;
 - ii. **Establishment** mean those portions of a fixed commercial premises or other premises that are openly accessible to members of the public and that are used for the purposes of offering goods or services (including religious services) to members of the public and include a mall or other structure containing a number of commercial premises, and, without limiting the generality of the forgoing, include the following:
 - Retail stores;
 - Convenience stores;
 - Malls/plazas;
 - Restaurants/bars/taverns;
 - Banquet halls, convention centres and other event spaces;
 - Personal service settings;
 - Grocery stores and bakeries;
 - Gas stations;
 - Farmer’s markets;
 - Areas of Mechanics’ shops/garages/repair shops, which are open to the public;

- Car dealerships;
- Indoor play zones/arcades/art studios or galleries;
- Cinemas/performing arts/theatres/museums;
- Indoor arenas/sporting venues as a spectator;
- Public indoor tours of facilities;
- Casinos/charitable gaming halls including horse racing;
- Fitness facilities/gyms/indoor sports facilities/studios;
- Common areas of hotels/motels/short term rentals; and
- Churches, mosques, synagogues, temples or other faith settings.

Private Commercial Vehicle means a vehicle used for provision of commercial transportation services to members of the general public (bus/taxi/limo/ride share) but does not include a vehicle that is owned or operated by a governmental authority.

Notwithstanding the foregoing, the following are not subject to this Order even if they would otherwise fall within the definition of an Establishment:

- Day camps;
- Day care centres;
- Schools;
- Libraries;
- Community centres;
- Offices that are not open to members of the public;
- Professional offices where clients receive purchased services (e.g. lawyer's/accountant's office) that are not open to members of the public;
- Public transportation (bus/train);
- Hospitals;
- Independent health facilities; and
- Offices of regulated health professionals.

The areas of an Establishment that are subject to the Face Covering requirements of this Order are:

- Any areas in which customers interact with one another or with staff members, OR
- Any areas that are open or accessible to members of the public,

Except where: The area is outside, whether or not the area is covered (e.g. a restaurant patio).

Persons must wear their Face Covering inside the Establishment at all times, unless it is reasonably required to temporarily remove the Face Covering for services provided by the Establishment. For greater clarity, and without limiting the generality of the foregoing, these instances include the following:

- While eating or drinking;
- While participating in a religious rite that involves eating or drinking or otherwise reasonably requires the removal of the mask;
- While exercising or participating in an activity that requires physical exertion; and
- While participating in an activity where a Face Covering may become wet.

For greater clarity, examples of areas that are or are not subject to the Face Covering requirements of this Order are as follows:

- iii. A **Face Covering** means a medical mask or a non-medical mask or other face coverings such as a bandana, a scarf or cloth that covers the mouth, nose and chin ensuring a barrier that limits the transmission of infectious respiratory droplets.
- iv. A **Person** means any customer, patron, employee or visitor, who enters the Establishment.

Severability

- 2. If a court of competent jurisdiction declares any provision or part of a provision of this Order to be invalid, illegal, unenforceable or of no force and effect, it is my intention in enacting this Order that the remainder of this Order will continue in force and be applied and enforced in accordance with its terms to the fullest extent possible according to law.

Actions to be taken by persons who own or operate an Establishment in the County of Wellington

- 3. Every person who owns or operates an Establishment in the County of Wellington shall take the following actions effective 12.01am on September 18, 2020:

- 1. Prohibit Persons from entering the premises of the Establishment or remaining in the premises or a Private Commercial Vehicle if the said Person is not wearing a Face Covering.**

The Face Covering must be worn inside the Establishment at all times, unless it is reasonably required to temporarily remove the Face Covering for services provided by the Establishment.

A Person shall be exempt from wearing a Face Covering on the premises if:

- a. The Person is a child under the age of two (2) years; or a child under the age of five (5) years either chronologically or developmentally and he or she refuses to wear a face covering and cannot be persuaded to do so by their caregiver;
- b. Wearing a Face Covering would inhibit the Person's ability to breathe in any way;
- c. For any other medical reason, the Person cannot safely wear a Face Covering such as, but not limited to, respiratory disease, cognitive difficulties or difficulties in hearing or processing information;
- d. The obligation to provide reasonable accommodation under the Ontario Human Rights Code requires exemption from this requirement.




4. This Order shall come into force and take effect at 12:01 am on September 18, 2020 and Emergency Order No. 2 is rescinded and replaced with this Order.

TO: All persons who own or operate a Commercial Establishment or other Establishment (hereinafter collectively referred to as an Establishment) or a vehicle providing private commercial transportation (hereinafter referred to as a Private Commercial Vehicle) in the jurisdiction of the Wellington-Dufferin-Guelph Health Unit.

I, Dr. Nicola Mercer, Medical Officer of Health for the Wellington-Dufferin-Guelph Health Unit, ORDER YOU TO TAKE THE FOLLOWING ACTIONS, effective 12:01 a.m. on September 18, 2020:

- 1. Prohibit Persons from entering the premises of the Establishment or remaining in the premises or a Private Commercial Vehicle if the said Person is not wearing a Face Covering.** The Face Covering must be worn inside the Establishment at all times, unless it is reasonably required to temporarily remove the Face Covering for services provided by the Establishment.

A Person shall be exempt from wearing a Face Covering on the premises if:

- a. The Person is a child under the age of two (2) years; or a child under the age of five (5) years either chronologically or developmentally and he or she refuses to wear a face covering and cannot be persuaded to do so by their caregiver;
 - b. Wearing a Face Covering would inhibit the Person's ability to breathe in any way;
 - c. For any other medical reason, the Person cannot safely wear a Face Covering such as, but not limited to, respiratory disease, cognitive difficulties or difficulties in hearing or processing information; or
 - d. The obligation to provide reasonable accommodation under the Ontario Human Rights Code requires exemption from this requirement.
- 2. Ensure the availability of alcohol-based hand rub at all entrances and exits for the use of all Persons entering or exiting the Establishment or Private Commercial Vehicle.**

THE REASONS for this ORDER are that:

I am of the opinion, on reasonable and probable grounds, that:

- a. A communicable disease exists or may exist or there is an immediate risk of an outbreak of a communicable disease in the health unit served by me;
- b. The communicable disease presents a risk to the health of persons in the health unit served by me; and
- c. The requirements specified in this Order are necessary in order to decrease or eliminate the risk to health presented by the communicable disease.

I am also of the opinion that the delivery of notice of this Order to each and every member of the class to whom it is directed is likely to cause a delay that could significantly increase the risk to the health of any person residing in the jurisdiction of the Wellington-Dufferin-Guelph Health Unit, so notice shall be provided through the public media and the internet via posting at: www.wdgpUBLICHEALTH.ca.
