NOTICE OF COMPLETE APPLICATION

DRAFT PLAN OF VACANT LAND CONDOMINIUM

Township of Centre Wellington

TAKE NOTICE that the County of Wellington has received a complete application for a Proposed Draft Plan of Vacant Land Condominium pursuant to the *Planning Act*, R.S.O., as amended. File Number 23CD-26001.

THE LAND SUBJECT to the application for a proposed Draft Plan of Vacant Land Condominium is located on Block 40, Reg. Plan 61M-252 Township of Centre Wellington. The land is illustrated on the key plan below.

THE PURPOSE and effect of the proposed plan is to create a four unit Vacant Land Condominium to facilitate the development of four separate four storey apartment buildings containing 181 total units. Also includes common elements and 256 exclusive use parking stalls.

OTHER RELATED APPLICATIONS

Application was made to the Township of Centre Wellington which was granted – Site Plan Approval under Section 41 of the Planning Act to application file number SP005-2024 on February 12, 2025.

NEED TO MAKE SUBMISSIONS

- i. If a person or public body would otherwise have the ability to appeal the decision of the Corporation of the County of Wellington but does not make oral submissions at a public meeting, if one is held, or make written submissions to the Corporation of the County of Wellington in respect of the proposed plan of condominium before the approval authority gives or refuses to give approval to the draft plan of condominium, the person or public body is not entitled to appeal the decision to the Ontario Land Tribunal.
- ii. If a person or public body does not make oral submissions at a public meeting, if one is held, or make written submissions to the Corporation of the County of Wellington in respect of the proposed plan of condominium before the approval authority gives or refuses to give approval to the draft plan of condominium, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
