REVISIONS:

- Updates to show full lot fabric for single detached dwellings and townhouse dwellings
- The servicing block on the previous plan (Block 22) was added to the south Stormwater Management Pond Block (formerly Block 22, now Block 229) which resulted in an increase in area.
- Block 23 from the previous version has been removed and is now identified as a 10 metre
 wastewater servicing corridor within the north Storm Water Management Block (formerly
 Block 20, now Block 228), the Medium Density Block (formerly Block 15, now Block 222)

and NHS Block (formerly Block 16, now Block 226). An easement will be provided on Block 222.

- 0.3 metre reserves have been removed from 90-degree elbows
- The plan has been updated with 6 metre x 6 metre daylight triangles rather than roundings
