Subsidized Housing Application

Eligibility Requirements

To be eligible for subsidized housing, you must meet all of the following conditions:

- At least one member in the household must be 16 years or older
- All members of the household must be legal residents of Canada
- No member of the household is currently under a deportation, departure or exclusion order to leave Canada
- No member of the household has been convicted of an offence in relation to rent-geared-to-income assistance or found by a court of law to have misrepresented their income for the purposes of receiving rent-geared-to-income assistance
- Total value of all assets owned by you and all members of your household who are over the age of 16 must be less than \$50,000 for a single or \$75,000 for a family. Bank accounts and investments are examples of assets. Some assets, including Registered Education Savings Plans and Registered Disability Savings Plans are not counted toward the limit, but you must still declare them
- If you own a house, you must agree to sell it within six months of being housed
- You must be able to live independently, with or without supports

To apply using the paper application, follow the instructions below:

- Complete all sections of the application form. If your application is incomplete, you will not be placed on the waiting list
- Provide proof of status in Canada for all members of the household
- All household members 16 years of age or older must sign the Release, Consent and Declaration
- You may be asked for proof of any information you give in your application

If you need any assistance, have any questions about completing the application or if this information is required in an accessible format, please contact Applicant Services at the above number.

Any changes in income or the number of individuals who will be living in your unit need to be reported to the County of Wellington, Housing Services within thirty (30) days of the change.

It is important that you file your income taxes yearly and provide us with your most recent Notice of Assessment

Tell us immediately if you move or if your telephone number changes. If we are unable to contact you, your application may be removed from the waiting list, and we may be unable to offer you housing.

Questions and Answers for Social Housing

When will I receive an offer?

When your name gets to the top of the list for the buildings you have selected and been approved for. The list is kept in order of the date we receive your application.

Are there any special circumstances that would enable me to obtain housing sooner?

Special Priority is assigned to victims of domestic violence or human trafficking.

Local Priority

- Uninhabitable Housing-those living in condemned housing or housing that has recently become uninhabitable or destroyed
- Family Reunification-those whose children are in the care of a child protection agency and who will be reunited with one or both of their parents if adequate housing is obtained; or those whose children will be taken into the care of a child protection agency if the family cannot obtain adequate housing on their own.
- Hospital Discharge-those awaiting release from hospital or other time-limited treatment facility, and cannot return to the former place of residence due to modifications required to the home.

Contact our Housing Clerk if you think your household might qualify for a priority.

Can I choose where I want to live?

Yes. When you apply for housing, you can select where you want to live. You can choose one or many locations. Your name will be added to the waiting list for each location where you are eligible.

It is important to know that you only have one refusal in total and after that you will no longer be eligible. (Your file is cancelled.)

Therefore, select only the areas where you would like to live. You can request changes to your building selections at any time, by contacting Applicant Services.

Do I get to choose the unit size I want?

You can indicate what type of unit you would like to live in, however your choice will be subject to occupancy standards that apply to households of your size.

How much rent can I expect to pay?

Rent-gear-to-income assistance is based on 30% of your gross monthly income from all sources, or if you are receiving Ontario Works or the Ontario Disability Support Program, a social assistance rent scale. Additional charges may apply depending on the building.

How long will it take me to get a unit?

The length of time before a unit becomes available will vary depending on the locations you choose. It may take some time because of the small number of vacancies.

How do I know that my application has been received?

When we receive your application, we make sure that it is complete and that all the documents you must provide are included. We will write to you as soon as possible if your application is complete. If we are missing information or documents, we will contact you, by mail, to let you know what information we need. You will have thirty (30) days to provide this information/documentation or your application will be cancelled. When your application is complete, we will send you a letter telling you whether or not you are eligible for rent-gear-to-income assistance.

How will I be contacted for an offer?

Since units are rented promptly, housing providers require a way to contact you, by telephone number and/or email. There is a time limit for how long a unit will be held for you, so it's important that you keep your contact information up to date.

How do I update or make changes to my application?

You can register for an online account at www.wellington.ca/housing. You can also contact the Centralized Waitlist at 519.837.5492 x4060. A Housing Clerk will assist you with changes or updates to your housing application.

In order to remain on the waitlist, you must notify our office within thirty (30) business days with any changes in the information provided on your application such as changes to your address, telephone number, email, your contact person or household members. Not keeping your information up to date may result in your application being cancelled on the waiting list.

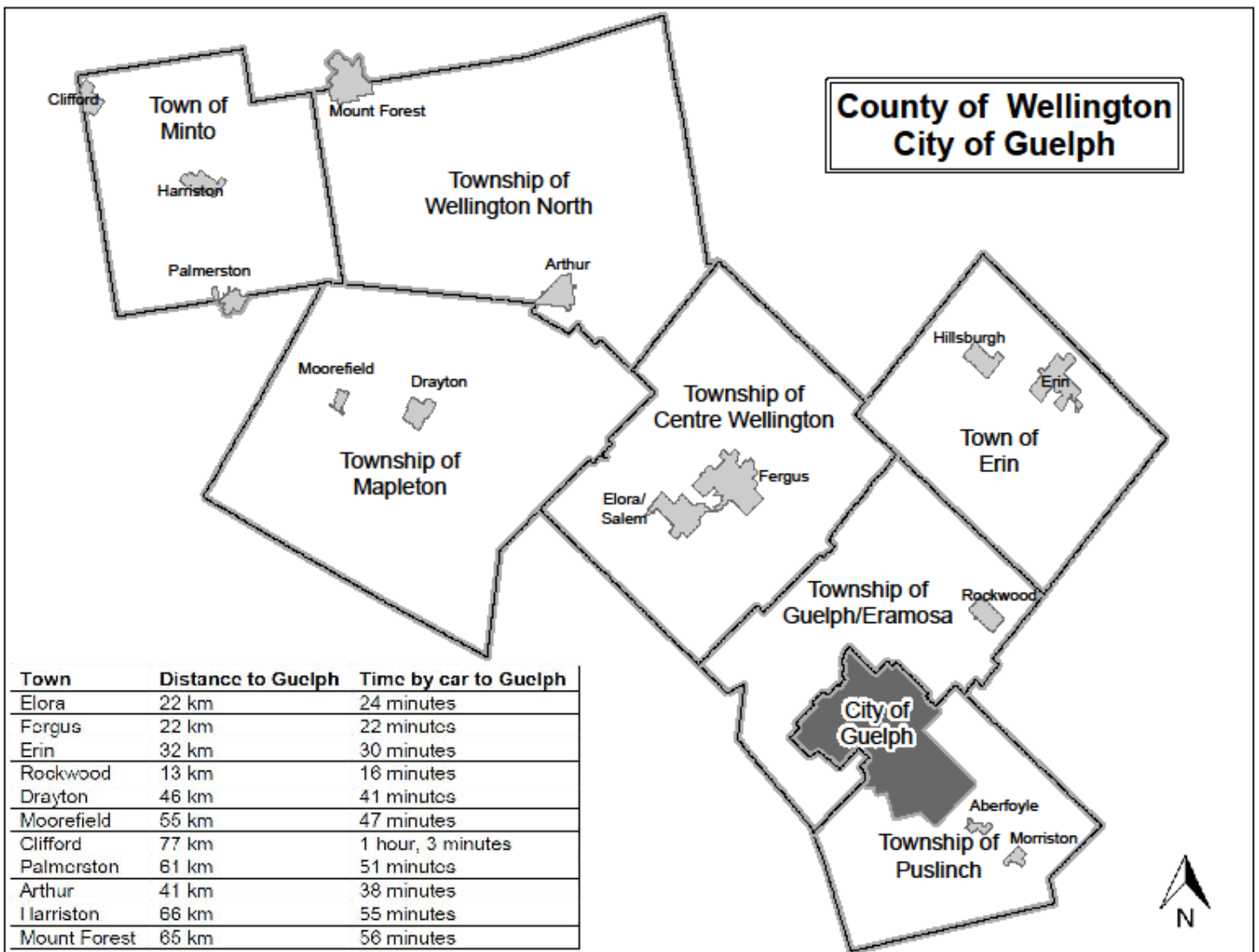
