NOTICE OF COMPLETE APPLICATION

FOR A PROPOSED OFFICIAL PLAN AMENDMENT
TOWNSHIP OF PUSLINCH
COUNTY OF WELLINGTON

TAKE NOTICE that the County of Wellington has received a complete application for a revised proposed Official Plan Amendment pursuant to the Planning Act, R.S.O., as amended.

THE LAND SUBJECT to the proposed Official Plan Amendment File Number OP-2006-06 is located on Part Lots 7, 8 & 9, Concession 10, Township of Puslinch (see key map below).

THE PURPOSE and effect of the proposed Official Plan Amendment is to expand the Hamlet of Arkell by redesignating the subject lands from Prime Agricultural and Secondary Agricultural to Hamlet Area to facilitate a residential subdivision.

OTHER RELATED APPLICATIONS the Township of Puslinch has received a complete application for a Zoning By-law Amendment File Number D14/KUK.

IF YOU WISH to be notified of the decision of the proposed County Official Plan Amendment, or of the refusal of a request to amend the official plan, you must make a written request to Aldo Salis, Director of Planning and Development (address below).

IF A PERSON or public body would otherwise have an ability to appeal the decision of the Corporation of the County of Wellington to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Corporation of the County of Wellington before the proposed official plan is adopted, the person or public body is not entitled to appeal the decision.

IF A PERSON or public body does not make oral submissions at the public meeting or make written submissions to the County of Wellington before the proposed Official Plan Amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

NOTE: Any verbal or written comment/statements submitted to the County of Wellington regarding this application is being processed under the Planning Act and may be made public as part of the process.
