NOTICE OF COMPLETE APPLICATION

FOR A PROPOSED OFFICIAL PLAN AMENDMENT
TOWNSHIP OF PUSLINCH
COUNTY OF WELLINGTON

TAKE NOTICE that the County of Wellington has received a complete application for a proposed Official plan Amendment pursuant to the Planning Act, R.S.O., as amended.

THE LAND SUBJECT to the proposed Official Plan Amendment File Number OP-2025-11 is located on 2809 Townline Road; Pt. Lot 1, Concession 2 Township of Puslinch (see key map below).

THE PURPOSE and effect of the proposed Official Plan Amendment is to redesignate the subject site from Secondary Agricultural Area to Rural Employment Area and Policy Area (PA7-X) to facilitate Industrial, limited Commercial, Retail and a Gas Bar uses.

OTHER RELATED APPLICATION

An application for zoning by-law amendment has been filed with the Township of Puslinch.

FUTURE PUBLIC MEETING a public meeting will be scheduled in the future.

IF YOU WISH to be notified of the decision of the proposed County Official Plan Amendment, or of the refusal of a request to amend the Official Plan, you must make a written request to Director of Planning and Development (address below).

IF A PERSON or public body would otherwise have an ability to appeal the decision of the Corporation of the County of Wellington to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Corporation of the County of Wellington before the proposed official plan is adopted, the person or public body is not entitled to appeal the decision.

IF A PERSON or public body does not make oral submissions at the public meeting or make written submissions to the County of Wellington before the proposed official plan amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
